Delta Air Lines generally processes refunds within **7–10 business days** for credit/debit cards and **up to 20 business days** for other payment types.

If your refund has **not been received within the expected timeframe**, you can dispute it by contacting Delta directly.

🧩 Why Refunds May Be Delayed

Refunds can be delayed for several reasons:

1. **Third-party bookings:** Tickets purchased via OTAs (Expedia, Priceline, etc.) may require coordination with the agency.


