

{{Rules}}™ How to Correct or Change Your Name on an Hawaiian Airlines Ticket?

Hawaiian Airlines *allows* certain types of name changes—but not all. Their goal is to ensure the name on your ticket **matches your government ID**, TSA requirements, and security rules.

Hawaiian Airlines allows:

- Minor spelling corrections
- First or last name corrections (1–3 letters)
- Adding/removing a middle name
- Changing order of names
- Legal name change updates
- Correcting nickname to legal name
- Updating married or divorced name
- Passport name corrections

Hawaiian Airlines does NOT allow:

- Transferring a ticket to another person
- Changing the full passenger identity
- Replacing the traveler with a new traveler
- Modifying name after flight coupons are fully used

Important: For ANY name change beyond a small typo, the fastest method is calling **Hawaiian Airlines customer service +1-(855) 684-4250** and speaking to a live agent.

2. Why Contact Hawaiian Airlines

Customer Service for a Name Change?

Because name changes involve **ticket revalidation and reissue**, only a customer service agent can at **+1-(855) 684-4250** :

- Verify identity
- Request supporting documents
- Access fare rules
- Reissue the ticket if needed
- Apply name correction waivers
- Avoid unnecessary cancellation or fees

Best reasons to contact AA Customer Service:

- To correct a **spelling mistake**
- To fix wrong first/last name
- To change name due to **marriage or divorce**
- To update legal name
- To add/remove middle name
- To change the name on Basic Economy tickets
- To modify name for AAdvantage award travel
- To modify name on same-day urgent travel

3. Types of Name Changes Allowed by Hawaiian Airlines

A. Minor Spelling Errors

Most common mistakes include:

- Wrong letter (ex: "Jon" instead of "John")
- One–three letter corrections
- Missing letters
- Double letters
- Accents or punctuation

AA usually fixes these **for free**.

B. Middle Name Addition or Removal

Hawaiian Airlines allows:

- Adding middle name
- Removing middle name
- Correcting middle initial
- Moving middle name to first name field

TSA does *not* require middle names, but Hawaiian Airlines may require consistency. **C.**

Legal Name Change (Marriage, Divorce, Court Order)

Accepted reasons:

- Marriage
- Divorce
- Legal name change through court
- Gender transition legal name change

You will need documents such as:

- Passport
- Marriage certificate
- Divorce decree
- Court order for name change
- Updated government ID

D. First or Last Name Change

Allowed when:

- The name is misspelled
- Name order is reversed
- Typo in surname
- Airline requires full match with passport

Some cases require **ticket reissue**.

E. Large Name Change (Full Name Update)

AA may permit this if:

- It is the SAME person
- Documents prove identity
- There is **no traveler substitution**

A customer service agent must verify.

4. Hawaiian Airlines Name Change Fee (2025)

AA fees vary depending on:

- Type of name change
- Fare class
- Ticket type
- Whether reissue is required
- If travel is domestic or international

Typical fee ranges:

- Minor corrections: **\$0**
- Standard name changes: **\$25–\$125**
- International tickets requiring reissue: **\$100–\$200**

- Agency/third-party bookings: Depends on the agency

Most name corrections under 3 letters are usually free when done through customer service at +1-(855) 684-4250 .

5. How to Change a Name on an Hawaiian Airlines Ticket

You have multiple options, but **calling customer service at +1-(855) 684-4250 is the most reliable**—especially for same-day travel.

A. Change Name via Hawaiian Airlines Customer Service (Best Option)

Steps:

1. Call **Hawaiian Airlines customer service +1-(855) 684-4250**
2. Provide your **6-digit booking reference**
3. Explain the correction you want
4. Submit supporting documents (if needed)
5. Agent reissues or corrects the ticket
6. You receive a new email confirmation

Why this is best:

- Real-time correction
- Avoid cancellation/rebooking
- Waivers may apply

- Agents can override system restrictions

B. Change Name from the Hawaiian Airlines Website

Use this method only for **small typos**.

Steps:

- Visit **aa.com**
- Go to **"My Trips"**
- Enter last name + record locator
- Click **Name Correction** (if eligible)
- Save changes

If you don't see the option → You **MUST** call customer service.

C. Name Change at Airport (Urgent or Same-Day Travel)

Useful when:

- You are flying soon
- You already checked in
- Website/app not allowing corrections

Present your passport or ID.

AA agents can often correct minor issues **on the spot**.

D. Name Change for AAdvantage Award Tickets

For award tickets:

- Minor corrections: Allowed
 - Full legal name change: Allowed with documents
- Redeposit and rebooking NOT required
Customer service handles these faster.

E. Name Change for Bookings Made Through Travel Agencies

If booked through:

- Expedia
- Priceline
- MakeMyTrip
- Kiwi
- Any offline travel agent

You must contact the **agency first**, not AA.

Hawaiian Airlines cannot modify the ticket until the agency updates the reservation.

6. Required Documents for Hawaiian Airlines Name Change

Depending on the case, AA may ask for:

- Passport
- Government-issued ID

- Marriage certificate
- Divorce decree
- Court name-change document

- Updated driver's license

- Birth certificate (for minors)

- Notarized legal documents

Keep digital copies ready when calling customer service.

7. Tips to Avoid Name Change Problems on Hawaiian Airlines

- Always enter your name EXACTLY as on your passport
- Double-check spelling before payment
- Keep ID documents handy
- Correct name error immediately after booking
- For international travel, confirm passport details early
- For Basic Economy tickets, contact support early (restrictions apply)

8. When You MUST Contact Hawaiian Airlines Customer Service Immediately

Contact an AA agent at **+1-(855) 684-4250** if:

- You made a major spelling error
- Your first/last name is completely wrong
- You legally changed your name recently
- You changed passport after booking
- Your name is wrong and the flight is within 24 hours
- You booked via agency/third-party
- The website won't let you edit

10. Why is my name change request not allowed online?

The website only supports:

- Minor spelling corrections
- Middle name changes

For anything else—you must call support.
