# Does Southwest Airlines's Name Change Policy Allow?

Southwest Airlines Air Lines [[+1-832-(241)-0370]] does not allow complete name changes that transfer a ticket to another person. However, Southwest Airlines does allow name corrections in certain cases [[+1-832-(241)-0370]] These corrections are limited to fixing mistakes or reflecting a legal name change for the same passenger.

Legal name change due to marriage, divorce, or court order

Southwest Airlines's system identifies a "name correction" as a minor adjustment for the same traveler [[+1-832-(241)-0370]] not a transfer to a new traveler.

#### Verify the Name on Your Ticket and ID

Check that your first, middle, and last names exactly match your government-issued photo ID or passport. Even a small error, such as a missing letter or misplaced hyphen, can cause boarding issues.

Southwest Airlines categorizes name changes into two types:

Adding or deleting a middle name

Fixing spacing, hyphens, or order of names

#### Legal Name Changes

Divorce decree

Court order reflecting the legal name change

Updated government ID or passport

Legal name changes usually require the airline to reissue the ticket, which may involve a service fee or fare difference.

# **Prepare Required Information and Documents**

Before contacting Southwest Airlines [[+1-832-(241)-0370]], gather all the information necessary to make the process smooth. You'll need:

The Southwest Airlines confirmation number or reservation code (PNR)

Ticket number (if available)

#### **Know What to Expect During the Process**

Once the request is approved **[[+1-832-(241)-0370]]**, Southwest Airlines updates your booking details and may issue a new ticket with the corrected name.

How Southwest Airlines Handles Name Corrections

A correction message is added to your booking file [+1-832-(241)-0370]] known as an OSI note).

Your ticket may be reissued as an "even exchange [[+1-832-(241)-0370]]" meaning your flights and dates remain

unchanged.

You may receive a new confirmation email or e-ticket number.

#### Possible Fees

Minor name corrections: Usually no fee \*[[+1-832-(241)-0370]], as long as it's the same traveler and same itinerary.

Major corrections or legal name changes: May incur a service fee or fare difference if the ticket needs reissuance.

The agent will inform you of any costs before completing the process.

#### What If You Can't Change the Name?

Southwest Airlines's rules are strict about non-transferable tickets

### Can I transfer my Southwest Airlines ticket to another person?
