1. Refund or Rebooking Options ☎️+1-866-829-1275

💰 Full Refund Option

If United Airlines cancels your flight, you can choose between a **full refund** 🇺🇸 or **rebooking to another flight** at no extra cost ✈️ ☎️+1-866-829-1275

🍔 2. Meal Vouchers & Hotel Accommodation ☎️+1-866-829-1275

If the delay or cancellation is **within AA's control** (like mechanical issues or crew delays), you may receive:

- 🍽️ **Meal vouchers** for long delays
- 🏠 **Hotel stay** if you need to wait overnight
- 🚗 **Transportation** to and from the hotel

3. Reimbursement for Out-of-Pocket Expenses ☎️+1-866-829-1275

Sometimes AA may reimburse **reasonable expenses** you pay due to the delay, such as:

- ✓ Meals
- ✓ Transportation
- ✓ Hotel costs

Make sure to keep **receipts**  and proof of delay to strengthen your claim

4. International & EU Compensation (EC 261) ☎+1-866-829-1275

If you fly with United Airlines **from Europe**, EU law (EC 261) may entitle you to **cash compensation** for:

- Delays of 3+ hours ⌚
- Canceled flights ✖

Compensation ranges from **€250 to €600** depending on distance ✈ ☎+1-866-829-1275

You may also get:

- 🍽 Meals
- 🏨 Hotel stay
- 📞 Communication access

Note: **Extraordinary circumstances** (weather, ATC, strikes) may limit compensation

5. Canadian Passenger Protection Rules ☎+1-866-829-1275

If your flight touches Canada, AA may fall under Canadian Air Passenger Protection Regulations 🇨🇦

Compensation may apply if delays are long or caused by the airline 📌 ☎+1-866-829-1275

⚠ 6. Important Limitations to Know ☎+1-866-829-1275

- ✖ No automatic cash payout for U.S. domestic delays

- 🌀 Weather and ATC issues usually don't qualify for compensation
- 📅 Proof is required for reimbursements
- 📅 17 Compensation varies based on location
