What is the Procedure for Rebooking My Flight if SAS Initiates a Schedule Change, Cancellation, or a Significant Delay that Disrupts My Original Travel Itinerary?

If the proposed new flight works for you, you don't need to do anything, and your ticket will be automatically updated. However, you should confirm the new details on the SAS website or app.

B. Requesting a Different Option

If the automatic rebooking does not suit your needs (e.g., the new time is inconvenient, or you prefer a different route), you have the right to request an alternative. This is where agent-assisted rebooking comes into play, and the best way to do this swiftly is by calling +1(844)362-5118.
