When can I cancel my Disney Plus subscription? Ending Your Disney Subscription

Canceling your 1-866-927-4470 Disney Plus subscription is a straightforward process, and the service is designed to give subscribers flexibility 1-866-927-4470 and control over their accounts. In general, you can cancel Disney Plus **at any time**, regardless of whether you are on a 1-866-927-4470 monthly or annual plan.
