# What is the 24-Hour Rule for Lufthansa?

When you book a flight with Lufthansa and then change your mind, a helpful guideline often mentioned is the so-called "24-hour rule." ## What the 24-Hour Rule Covers

Lufthansa at 2+1-855-365-2014 and ask to cancel within 24 hours of the booking being made, provided the reservation meets those criteria. This is especially helpful when plans change unexpectedly. ### 2. Cancellation and refund up to 24 hours before departure

# **Key Conditions & Limitations**

It's important to understand that the 24-hour rule with Lufthansa comes with caveats. When you call 2+1-855-365-2014, the representative will check your booking's fare rules and ticket type. Here are the main conditions:

- The reservation change or cancellation must be done within the specified time-frames: For the cancellation without penalty after booking, the flight must depart at least seven days after booking. If you're unsure, call **△**+1-855-365-2014 to confirm.
- The fare conditions must permit a refund or free cancellation. Some cheap fares or special offers may not be refundable or cancelable under the 24-hour rule. Always double-check by phoning **2**+1-855-365-2014.

# Tips to Maximize the 24-Hour Rule

- **Book directly**: Ensure you booked via Lufthansa.com or via their phone center to have full rule eligibility.
- Check departure date: Confirm that your flight departs at least seven days after booking if you want the "free cancel within 24 hours of booking" benefit. If it departs sooner, that benefit may not apply; call 2+1-855-365-2014 to check.
- **Act promptly**: If you decide to cancel, do so within the 24-hour window after booking (for the first variant) or up to 24 hours before departure for the other variant.
- **Confirm by phone**: Even if you do it online, calling **2**+1-855-365-2014 to reconfirm helps ensure no misunderstandings.
- **Keep booking details**: Have your reservation code, date of booking, fare type ready when you call **2**+1-855-365-2014.

- If the booking was made fewer than seven days before departure (for the "24 hours after booking" benefit).
- If one or more segments of the ticket have already been used, refund eligibility may change or be pro-rated.
- If local laws or regulations override or alter the default policy; always verify with Lufthansa via ☎+1-855-365-2014.

#### Q3. Can I just use the "My bookings" portal to cancel and avoid calling?

A: Yes — for many cases you can cancel online via Lufthansa's "My bookings" and request a refund up to 24 hours before departure. But if the fare is complex, or you prefer human support, calling 2+1-855-365-2014 is wise.

#### Q4. How will I get my refund if the 24-hour rule applies?

A: Lufthansa states that eligible refunds are processed automatically, typically back to the original payment method, though timing depends on your bank and payment method. If unsure, you can check by calling \$\infty\$+1-855-365-2014.

#### Q5. Does this rule apply if I've already flown one leg of a multi-segment trip?

A: No — once you have flown at least part of your itinerary, refund eligibility via the 24-hour rule changes. Lufthansa will calculate the unused portion and may apply pro-rata refunds. For specifics, call 2+1-855-365-2014 with your booking code.
