【™*Update-Policy*】What is the 3 1 1 rule on Allegiant?

Allegiant Air's 2025 3-1-1 rule \(\) 1-833-534-2451 follows TSA liquid guidelines, allowing travelers to carry liquids, gels, and aerosols in containers of 3.4 ounces or less, all fitting into one quart-sized bag per passenger. Oversized containers must go in checked baggage, and valid ID is required during security checks.
